REQUIREMENTS FOR DELAYED REGISTRATION OF BIRTH (For 17 Years Old And Below)

A. Request for a copy of negative certificate of birth records from:

B. Affidavit of two disinterested persons who might have witnessed or known the birth of the child.

C. Affidavit of out-of-town registration of birth (when applicable)

D. Any two (2) of the ff. Documentary evidences that show the name of the child, date and place of birth, names of parents. (Faithful photocopy only)

1. Baptismal certificate of records
2. School records/transcript of records
3. Medical records (yellow card/baby book)
4. Marriage certificate of parents
5. Certification from barangay civil registration agents certifying that the child was born in their area and the facts of birth of the child. (when applicable)
6. Others, as may be required by the MCR.
